7) MANAGEMENT:! The Majority decisions of the members of the committee which is not against the bye laws according to this rule the committee shall manage the Al Madrasathul Aliya Arabic College.

8. WORKING:+ As per the bye laws, as per the majority decision of the committee, the Committee shall have the full right to conduct all the affairs successfully .

10. That as per the rules mentioned in rule 2 of the committee, the committee shall have the right to appoint employees and to fix their salaries, ~~cool~~ and other decisions and to terminate their employment.

11. That if any vacancy arises in respect of the member of the committee by way of death or retirement then the committee shall have the right to nominate for such post.

12. That after issuing notices by one week in advance by the General Secretary atleast for a period of three months and to conduct meetings of the committee and such meetings and its earlier meetings, working report shall be presented by the General Secretary or the person appointed by himself the each such meeting ^{is} to be ordered without notice\$, the decisions of such meetings shall be ratified by the subsequent committee members.

13. The Qoram of the committee shall be atleast 5 members and they shall be present and if the subsequent two meetings held without qoram then for conducting third meeting no qoram shall be needed.

14. (a) That in order to pass orders the ratification of members then present shall ratify it if while on casting

15. The Decision of the committee shall be recorded in the book of the president and the person who is presiding over it shall sign it.

16. If without any valid reasons any members fails to appear for the committing meetings continuously for 3 meetings, the the membership of such members shall be cancelled.

17. The committee president shall work for all the benefit and welfare of the committee/and shall sign all records passed by the committee.

18. If the President think fit to carry out any meeting then the president shall at the request of the Gen Secretary to call meetings and the Secretary shall call for meetings if the Gen Secretary does not do so then the president shall have the right to call for meetings.

19. Vice President perform the work of the president and shall help the president and shall attend in his absence shall perform on giving authorisation and shall perform all his works

20. Under the guidance of the committee Gen Secretary shall perform all the affairs on behalf of the committee as mentioned above.

(A) To keep in custody of one register book show the name and

secretary shall sign have the right and as per the bill shall be taken from the Khajanji. *Ex. 20000/-*

(K) In case for the purpose of the committee demand money and in fund of the committee there the amount is not available then the Gen. Secretary can spend the amount upto Rs.500/- and for that amount committee is responsible.

(L) Every year the accounts of Gen. Secretary, Khajanji shall be verified through the auditors appointed by the Committee and that report shall be presented before the meeting.

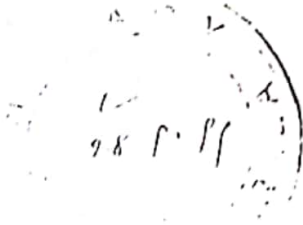
